#### SPECIAL RESOLUTION

OF

## THE HONG KONG ASSOCIATION OF THE HEADS OF SECONDARY SCHOOLS LIMITED

Passed on 22<sup>nd</sup> December, 2020

At an Annual General Meeting of the above-named Company duly convened and held at Kit Sam Lam Bing Yim Secondary School on 22<sup>nd</sup> December, 2020, the following Special Resolution was duly passed:-

"THAT the Articles of Association of the Company be and are hereby amended as follows:--

- (a) in Article 3:
  - (i) by inserting the words "for advancement of education" after "is established are" in the 1<sup>st</sup> line.
- (b) in Article 3(d), Article 3(e) and Article 3(f):
  - (i) by inserting the words "In furtherance of the objects of the Association but not otherwise," at the beginning of each of these articles.
- (c) in Article 3(f):
  - (i) by deleting the following words "similar persons, associations, companies, or other bodies" and replacing with the following words "persons, associations, companies or other bodies having similar

objects to the objects of the Association"; and

- (ii) by inserting the words "(the research findings are disseminated to the public)" after "research" in the 2<sup>nd</sup> line.
- (d) in Article 4:
  - (i) by deleting the following words "may be" and replacing with the following word "are" in the 1<sup>st</sup> line.
- (e) in Article 4(a), Article 4(m) and Article 4(n):
  - (i) by deleting the following words "the Clause 5 hereof" and replacing with the following words "Article 5 and Article 8 hereof" in the last line in each of these articles.
- (f) in Article 4(a), Article 4(j), Article 4(l) and Article 4(q):
  - (i) by deleting the following words "may be thought fit" and replacing with the following wordings "think fit" in each of these articles.
- (g) in Article 4(a):
  - by deleting the following words "charitable purposes" and replacing with the following words "for furthering the objects of the Association" in the 3<sup>rd</sup> line.
- (h) in Article 4(c):
  - (i) by inserting the words "On a non-profit making basis," at the beginning of this article.
- (i) in Article 4(e):
  - (i) by inserting the words "to the public" after "research" in the last line.
- (j) in Article 4(n):
  - (i) by deleting the following words "for charitable purposes calculated" in the 2<sup>nd</sup> line.

- (k) in Article 4(o):
  - (i) by inserting the following words "subject to the provisions of Article 5," at the beginning of this article; and
  - (ii) by inserting "or governing body of the Association" after "Executive Committee" in the 2<sup>nd</sup> line.
- (I) in Article 4(s):
  - by deleting the following words "Clause 5" and replacing with the following words "Article 5" in the 1<sup>st</sup> line; and
  - (ii) by deleting the following words "or their dependants" in this article.
- (m) in Article 4(t):
  - (i) by deleting the following words "altogether or mainly" in the 3<sup>rd</sup> line; and
  - (ii) by deleting the following words "and prohibit the payment of
  - (iii) dividend .... These Articles of Association" and replacing with the following words "provided that such companies, institutions, societies or associations shall prohibit the distribution of their income and property amongst their members to an extent as least as great as is imposed on the Association under or by virtue to Article 5 and Article 8 hereof" from the 3<sup>rd</sup> to the 7<sup>th</sup> line.
- (n) in Article 5(c):
  - (i) by inserting the following words "of the Association" after "governing body" in the last line.
- (o) in Article 9:
  - (i) by inserting a new Article as Article 9(i) with the following words

"Insert "Subject to Article 5 hereof," at the beginning of each of the Article 15(6)(c), Article 16(1) and Article 31(1) of Part B of the Model Articles."; and

- (ii) by inserting a new Article as Article 9(j) with the following words
  "Delete "(as to remuneration or otherwise)" in Article 16(1) of Part B of the Model Articles.".
- (p) in Article 8:
  - (i) by deleting the following words "Clause 5 hereof" and replacing with the following words "Article 5 hereof and this article" in the 8<sup>th</sup> line.
- (q) in Article 80:
  - by inserting the following words "having objects similar to the objects of the Association, and in accordance to the provisions in Article 8 hereof and" before "to be resolve" in the 3<sup>rd</sup> line.
- (r) Inserting new Article 81:
  - (i) by inserting a new Article as Article 81 with the following words "The Executive Committee must prepare annual financial statements for each accounting reference period as required by the Ordinance. The financial statements must be prepared to show a true and fair view and follow accounting standards issued or adopted by the Hong Kong Institute of Certified Public Accountants or its successors and adhere to all of its recommended practices. The Executive Committee must keep accounting records (including donation receipts) as required by the Ordinance.".
- (s) in Article 9:
  - (i) by inserting a new Article as Article 9(k) with the following words "Insert "Only in furtherance of the objects of the Association but not otherwise," at the beginning of each of the Article 29(1), Article 30 and Article 57(1) of Part B of the Model Articles.".
- (t) in Article 29:

- (i) by deleting the following words ",privileges" and "and privileges" in this article.
- (u) in Article 77(b):
  - (i) by deleting the following word "aims" and replacing with the following word "objects" in the last line.

AND THAT the Company Secretary of the Company is authorized to deliver this Special Resolution to the Registrar of Companies for registration."
